The following is a letter found in the Civil Case #11990 for divorce, JESSE PERRY vs. ADDIE PERRY, 27 May 1918.

June the 5 1918 Parkersberg, WVA

Well Mr. Williams I received the letter which I understand that my husband Jess Perry wants a divorce from me he mite sue for it but I am going to a pear a gain him and see that he dont get no divorce i am down sick now and it will half to bee put of till i get better so i am going to bring three witnesses there with me just as soon as i get better and see that he dont get any divorce and a nother thing he has not bine in the state of Ohio a year till some time in July he came here to tend his Fathers Death and stayed till July his father was berried in april and he stayed here and worked till some time in July and Jess Perry and i has bine married twice the first time we was married we got married in henderson wva a bout 12 years a go and the last time we was married was in Parkersberg WVa in 1912 You ask him if he hasent bine married to Addie Perry twice so all he has to do is to come here after me and treat me right and i will live with him but he will never bee divorced till death parts us for i am willing to fight the case just as soon as i get able to come. Please send me a card at once let me know where he is

STATE OF OHIO, COUNTY OF COLUMBIANA, SS. IN THE COURT OF COMMON PLEAS

PETITION

Hutchison Hart, Plaintiff

VS.

Theodore Petrakes, Alex Alexander and George Petrakes, doing business at East Liverpool, Ohio as The Olympic Confectionary,

Defendants

Plaintiff says that on, or before July 19, 1919, Defendants were engaged in business on the Diamond in said city as retail dealers in ice cream, soft drinks and in operating an eating house and restaurant, as a place of public accommodation. Plaintiff is a respectable colored man, of African descent and a citizen and resident of the United States of America, the State of Ohio. At said time and place, Plaintiff, accompanied by a white man, James Love, a respectable, law abiding citizen of said State, entered said place of business, and asked to be served at the counter or table, in said place of business, intended for and used by Defendants' patrons in said place of business. Defendants refused to serve Plaintiff in said place of business, solely and only because of his color and race, and in the presence and hearing of divers persons, maliciously intending to humiliate and insult Plaintiff, refused to serve him in their place of business, giving as a reason therefore, that they did not serve colored people. In violation of the General Code of the State of Ohio, the statutes of the United States, and the Constitutional rights of Plaintiff.

Whereby Plaintiff was damaged in the sum of \$500.00, for which he prays judgment with costs of action.

There was a summons on 20 August 1919 to the Sheriff of Columbiana County to notify Theodore Petrakes, Alex Alexander and George Petrakes, dba at East Liverpool, Ohio as The Olympic

Confectionary, that they were being sued. They were given until 20 September 1919 to answer the petition.

Alex Alexander, Theodore Petrakes and George Petrakes each answered the petition of the Plaintiff denying each and every allegation and asked for the petition of the Plaintiff be dismissed without day and recover his costs.

The following poem was found in a newspaper in a case file. It is from The Ohio Patriot: A Newspaper Devoted to the Interests of the Democratic Party, Tuesday, April 11, 1922.

We Wanted A Change -- We Got It

We were getting a dollar six-bits for our corn, We could sell every hide from the hoof to the horn--We wanted a change and we got it.

Now we're getting a quarter for corn. Its so cheap That we burn it for fuel, our toes warm to keep. We cant sell the hides so we bury them deep--But we wanted a change and we got it.

The poor workingman pulled down eight bucks a day, Now he's darned glad to work for half of that pay--But we wanted a change and we got it.

There was work and plenty for every man's son, And warm food and shelter when that work was done; Now millions are idle, heretofore there were none--But we wanted a change and we got it.

Mr. Wilson spent quite a long time "over there", For peace he was fighting, but what did we care-But we wanted a change and we got it.

Now all that we read is of golf and vacations, Gay week ends at summer resorts and plantations; Not what we expected from the head of a nation--But we wanted a change and we got it.

We were prosperous and happy, well fed and gay, Now millions of children go hungry each day--But we wanted a change and we got it.

Meanwhile we hear this, "It was certain to come --Reaction from war time," and war three years done. If we wanted a lemon, we sure did pick one--But we wanted a change and we got it. The following are excerpts from the column News Notes of 30 Years Ago, Thursday, April 16, 1891, found in The Ohio Patriot: A Newspaper Devoted to the Interests of the Democratic Party, Tuesday, April 11, 1922.

New Lisbon now has seventeen grocery stores or one to about every 130 inhabitants.

Officer elected for the current year for the West Beaver Sabbath school are: Supt. W. J. Adams, Asst. Supt. William Fife, Secretary Miss Eva McCormick.

W.A. Thompson, a member of the banking firm of Thompson and Co., of Salineville, while loading a stove had his left leg broken when the stove fell on him.

Nancy Black, an aged maiden lady went to the barn on her farm in Madison township to help get a horse up that had fallen down. The beast, in its struggles, knocked her down, fracturing one leg and dislocating her shoulder.

On last Wednesday while tearing down an old log house on the Miller farm about four miles east of Hanover, situated on the West Fork road near Ritchies Mill, workmen found seven thousand dollars in gold in a neatly tied package placed between the logs of the building. The money was turned over to be divided among the heirs to the Miller farm. It is supposed to have been placed there by Grandfather Miller, an early settler, who built the house.

GYPSIES MOVED

Answering a call from Charles Newhouse, north of Lisbon, Sheriff Lewis went to his farm Friday and ordered a gypsy camp of forty six persons to move. They were allowed until Saturday morning to vacate, which they did, going from there to West Virginia. They were up to date and traveled by motor car.

The following article is from The Buckeye State: The Paper That Goes Into The Farm Homes of Columbiana County, Monday, September 11, 1922. The headline has one monetary amount and the article has another.

DEMAND \$50,000 FOR TRAGIC DEATH

The peculiar accident which occurred in Salem last October, when Uriah K. Miller was killed by electricity in his home on South Howard street when his feet were placed against a metal steam radiator and he touched a metal table lamp burning upon the table, bases a \$60,000 damage action which was filed in the common pleas court on Friday by James A. George, administrator of his estate, against the Salem Lighting Company. Miller was married, and the action is filed in behalf of his wife and six months old babe.

The fatal accident is blamed upon the carelessness and negligence of the city lighting company in having permitted its transformers and wires to become defective and broken down, and to allow them to be without proper insulation. It is claimed that there was a pole containing wires and a transformer about 150 feet from the Miller home, and during the early evening of October 25th, while Uriah Miller was seated in a chair beside the table and reading lamp in his home, with his feet against a steam radiator, he undertook to adjust the lamp and had no soon touched it than powerful current passed through his body, causing complete paralysis and death within a few days. His feet, where they were rested against the metal radiator, were burned to a depth of one inch.

Upon looking up the civil case file #14669, 8 September 1922, the name of the administrator for the estate of Uriah K. Miller was James A. McGeorge not James A. George. Uriah's wife was Anna and the six month old child was Catherine. The sued amount was \$50,000. The jury found in favor of the Plaintiff. The Salem Lighting Company filed a Motion for New Trial for two reasons: Because the verdict was contrary to the weight of the evidence and contrary to law, and Because of error of the Court in its charge to the jury.

Election of officers for the ensuing year featured the Saturday morning session of the annual county convention of the Women's Christian Temperance Union, held Friday and Saturday of last week, in the First United Presbyterian church in East Palestine. Mrs. L.M. Kyes, East Palestine was elected president, Mrs. Margaret J. Moore of East Liverpool, vice-president; Mrs. Eva Leatherberry, Salem, corresponding secretary; Miss Edna Van Kirk, treasurer.

Mrs. John Santee gave an interesting memorial address, "Crusaders on the Platform."

"Prohibition in the Orient", the address of the convention was given Friday evening by Mrs. Mary J. Campbell of Lucknow, India, who has been engaged in missionary work there for several years. A pageant, which a score of children took part was presented under the direction of Mrs. Emma Sutherin.

Delegations were present from East Liverpool, Wellsville, Salem, Lisbon, Leetonia and other county towns.

CIVIL WAR VETS GET MORE MONEY

Lisbon and Columbiana county veterans of the Civil War and surviving widows of veterans, will be interested in the contents of a letter received by Richardson Arter, Lisbon from Senator Frank B. Willis at Washington, stating that the Burson bill, increasing the pension of old soldiers to \$72 per month, and that of soldier's widows to \$50, passed the senate on Friday afternoon and is now ready for the signature of President Harding. It is probable that the increased pension will be payable on October 4th, as after this quarter, which closed on September 4th, the pensions of both the old soldiers and widows, will be payable monthly. Senator Willis notified Mr. Arter at once when the bill passed the senate, knowing his interest in the same, and asking that he notify the old soldiers of the county.
