#### **OHIO PENITENTIARY FIRE**

This was a horrible fire that happened in the evening of April 21, 1930. The inmates had just finished their evening meal and had been locked down for the night when fire broke out in cell blocks G and H. Some of the guards delayed opening the cells for fear of a mass prison break. By the time the cells were open the fire and smoke had started taking a heavy toll. Stories of cruelty and inhumane behavior among both prisoners and guards circulated, but there were more stories of heroism and brotherhood. Two guards reported that prisoners had saved their lives. All toll 322 died as a result of the fire. The fire was intentionally started by three prisoners by the names of James Raymond, Clinton Grate and Hugh Gibbons. James Raymond later hung himself while in solitary confinement and the other two were convicted of second degree murder and sentenced to life imprisonment. This was one of the most tragic fires in the United States.

Three Columbiana Countians perished. They were:

KENNETH CROUCH - b. abt 1906; Salem, Ohio; no sentence or crime listed.

THOMAS DALBY - b. 1 Apr 1904; Wellsville, Ohio; no sentence or crime listed.

SAMUEL MANN - B. 4 SEP 1898; East Liverpool, Ohio; who was serving 1-5 years for manufacturing liquor.

There were several from Stark, Jefferson and Mahoning counties too.

New Lisbon Columbiana County Ohio, October 26th, 1857:

The foregoing is a correct report of the prisoners committed and discharged during the current year. There has been some sickness among the prisoners, but none of a violent character. The prisoners have been attended by a physician when their situationrequired treatment. There has been no labor performed by the prisoners; the rooms of the jail were white-washed three times a year, April, July and September; the rules furnished for the government of the Jail have been regularly furnished to the prisoners. They have also had Bibles and other useful reading matter. The prisoners were generally of cleanly habits. They were always furnished with good substantial food, such as is used by the citizens generally (unless they were otherwise sentenced).
