The following was found in Common Pleas Journal #10, November Term A.D. 1840. A great find if someone was looking for list of legal heirs or how the property was transferred.

Jacob Picket Administrator & Martha Bell Administratrix of the Estate of Smith Bell decd.

vs. Taylor McMillan et al

No. 61 August Term 1840. Petition to make a deed in this case notice of the Pendency of the petition being proven and the C.M. Aten guardian of Smith Bell, Mary Bell, Robert Bell and Martha Ann Bell minor heirs of Smith Bell deceased having answered and the rest of the defendants having shown no cause against the prayer of said petition and the court upon the examination of said petition answer & exhibits are of opinion that the equity of the case is with the complainants. And the Court do find that said Smith Bell did at the time alleged in said petition execute the said article of agreement. In which he covenanted to make and execute to said Moses Dickey a deed in fee simple for the said forty acres of land in said petition described.

The Court do further find that the said Smith Bell died without compleating said contract leaving the said Martha Bell a widow and the said Sarah wife of said Taylor McMillan, Joseph Bell, Hiram Bell, Isaac Bell, Smith Bell, Mary Bell, Robert Bell and Martha Ann Bell heirs at law. The Court do further find that the said Moses Dickey to whom the said land was to be conveyed died without receiving a deed for said premises having certain heirs at law.

And it appearing to the Court that the consideration of said land has been fully paid and that said petitioners have been appointed administrators of the Estate of said Bell decd. It is therefore ordered adjudged & decreed that the said petitioners make execute and deliver to the heirs at law of the said Moses Dickey deceased a deed in fee simple for said forty acres of land particularly described as follows: Beginning at the south west corner of the north east quarter of section 23 T11R2 in Columbiana County, Ohio and running thence east along quarter section line 80 rods, thence north 80 rods thence west 80 rods to the quarter section line thence south along said line 80 rods to the place of beginning.

The following was found in Common Pleas Journal # 10, page 308, April Term A.D. 1842. Legal proof for a pension for services rendered in Revolutionary War and legal heirs of the deceased.

Samuel Lyons in the Matter of Pension

In the matter of the claim of pension money due from the United States to the Representatives of Samuel Lyons, lately of Columbiana County Ohio deceased, it is proved by the oaths of George Shirtz and others, to the satisfaction of this Court that the said Samuel Lyons, deceased, was lately a resident of said Columbiana County, that during his lifetime he was entitled to a pension of eighty dollars per annum on account of services rendered the United States during the Revolutionary War, that the said Samuel dec'd on the 9th day of March A.D. 1842 leaving no widow, and leaving the following lawful children to wit: John Lyons, Samuel Lyons & James Lyons the only children of said deceased pensioner, which proof is ordered to be recorded.

The following newspaper clippings were found in Mattie Wilson's scrapbook in possession of the Lisbon Historical Society. Coleman was located on the St. Jacob-Logtown Road in the area where the parking lot is near mile 3 of the current bike trail.

THE COLEMAN RAPE CASE -- The examination of John Steffle before 'Squire James A. Martin, upon the charge of having attempted to rape Miss Florence Huddleston, of Coleman, attracted a curious throng to the council chamber last Thursday afternoon. The manner of the prisoner was wholly unconcerned on first entering court, and he even laughed and chatted with his friends. His face, at first sight, is not unprepossessing. Whether the florid complexion is natural or comes from dissipation, is doubtful. As the trial progressed he became uneasy and nervous, and repeatedly used his left hand in stroking his face. Miss Huddleston is a plain, dark complexioned girl, quite ignorant, and anything but attractive. She gave her testimony with much hesitancy, and seemed greatly embarrassed. G.W. Love, of this place, appeared for the State, and M.E. Taggart, of Leetonia, for the defense. After hearing the evidence, the 'Squire held Steffle for court in the sum of \$400, and in default he was remanded to jail.

Death of Judge Wallace.

Judge Wallace, one of the most able lawyers of Columbiana county, died at his home in New Lisbon at noon Saturday. He was buried on Tuesday. As the Judge had many relatives and friends in and around East Palestine we publish the following brief sketch of his life taken from The East Liverpool *Crisis*:

Jonathan Hasson Wallace was born in St. Clair township, Columbiana county, Ohio, October 31, 1828. He was, therefore, sixty-four years old at the time of his death. His father was born near Belfast, Ireland, and came to this country when about sixteen years old, and located in Washington county, Pennsylvania. He afterward came to this county, and died in 1830. The mother of the subject of this sketch was Mary Hasson, daughter of Jonathan Hasson, who came to Columbiana county about the year 1850 from Pennsylvania. Robert Wallace, the father of Jonathan, died when the latter was only two years old, and for the careful training he received in early life, and the liberal education he afterward obtained, he was indebted to the thrift and energy of his mother. This worthy woman lived until 1861. Judge Wallace's early boyhood days were spent on the home farm, rendering such assistance as he was capable of, and in the winter seasons attended the district school, where he obtained the elements of an English education. As he grew older he expressed a desire to obtain a liberal education, and his mother placed him in the Beaver, Pa., academy, where he spent two years under the instruction of Messrs. Olmstead, McClelland and Coulter. From there, he went to a select school in Calcutta, this county, taught by R.S. Elliott and D.C. Reed, where he remained for a short time. In the spring of 1843 he entered the junior class of Washington College, Washington, Pa., and graduated with credit in 1844, being the youngest in a class of twenty-five. He was only sixteen when he graduated. After leaving college, Mr. Wallace taught school for two years in the northern part of this county. In 1846, he entered the law office of Unbstaetter & Stanton (the latter the late E.M. Stanton, who was Secretary of War during President Lincoln's administration), in New Lisbon, where he remained until he was admitted to the bar in 1848. He then entered into partnership with his preceptors, which association continued until 1851, when it dissolved by the removal of the senior partner to Pittsburgh. From 1854 to 1857 he practiced in partnership with W.K. Gaston. From the latter date until 1876, he was without a partner. In '76, he associated himself with N.B. Billingsley.

Mr. Wallace was a Democrat, and took quite an active part in politics. In 1851 he was elected Prosecuting Attorney, and served two terms in that office. He represented this district in the Democratic National Convention at Chicago, in 1864, that nominated George B. McClelland for the Presidency. In 1875, without his knowledge or solicitation, he was nominated by his party for Common Pleas Judge of the fourth subdivision of the Ninth Judicial District, composed of Carroll and Columbiana counties, but was defeated. In 1882 he was elected to Congress, defeating William McKinley, Jr., and served one term. Governor Hoadly, in 1885 appointed him Common Pleas Judge in the fourth subdivision of the Ninth Judicial District to fill the unexpired term of Judge P.A. Laubie, resigned.

As a lawyer Judge Wallace, occupied a leading rank at the bar of Eastern Ohio. He had a very large law practice, and during his professional career was connected with many cases of decided prominence, among which may be mentioned the Mead murder trial, in 1875, the Wintergill murder trial, in 1878, and the Marlatt murder trial, in 1890. In the two last named he was counsel for the defendant. In the Mead trial he assisted the State in the prosecution, and his efforts upon this occasion were very able, his address to the jury being one of the finest and most convincing ever delivered in Columbiana county.

Personally Judge Wallace was very popular, and there was no man in the county who possessed the confidence and esteem of the public in a more marked degree. He was a man that no community can afford to lose. He was married August 9, 1848, to Elizabeth E., fifth daughter of the late Dr. George McCook, an early physician of Columbiana county. The issue of this union was four children, three of whom are living, viz: Mary, wife of N.B. Billingsley, Bennie, wife of Dr. H. Cunningham, and George. Mrs. Wallace died in 1881. Mr. Wallace was a man of great energy and perseverance, fine social qualities and umimpeachable integrity.

He filled the office of associate judge for the constitutional term and his fellow citizens placed such confidence in his integrity that they elected him repeatedly to the legislature of this state, and every situation in which he had been called to act, he sustained the reputation of an honest man and a friend to his country. (Nov. 22, 1828)
- BURBECK, JONATHAN: Died on Thur. last in Centre Twp., JONATHAN, son of ARTHUR BURBECK, aged about 12y. Yesterday his remains were deposited in the old cemetery near this place. (Feb.13,1830)

- BURKY, WIDOW. Died on the 12th inst in Salem Twp., Col.Co., the WIDOW BURKY, a member of the German Evangelical Reformed Church, in the 78th year of her age. At her funeral the Rev'd. J. KELLER delivered an appropriate discourse from Psalm 90, 5.6.7. (Sept. 29,1827)
- CLAPSADDLE, JOHN. Died on Sat. last at the farm of Mr. JOHN REESE, in this county, Mr. JOHN CLAPSADDLE, son of the late DANIEL CLAPSADDLE. The dec'd was a widower for several years and left 5 small children, all girls, to deplore the loss of the last remaining parent. (July 24, 1830)
- COBLENTZ, JOHN. Died on the 12th inst. at his farm in Beaver Twp. after a painful and lingering illness, which he bore with Christian fortitude and resignation, Mr. JOHN COBLENTZ, age 63y 4m 16d. (May 24,1828)
- COFFIN, ROBERT S. Died on the 7th ult. at Rowley Mass., Mr. ROBERT S. COFFIN, the "Boston Bard." (June 2,1827)
- CROWL, ELIZABETH. Died on Tues. morning last, of inflammation of the brain, Elizabeth, daughter of JACOB & MARY CROWL, age 9y 2m 2d. (May 1, 1830)
- DAVIDSON, SARAH. Died on Thur. morning the 2nd inst. of the consumption, MRS. SARAH DAVIDSON, aged 59y 2d. She was mother of 13 children. (Sep.11,1830)
- DAVIS, ANN BRADLEY Died on the 11th inst. after a short illness of only 33 hours MRS. ANN BRADLEY DAVIS, wife of EDWARD DAVIS, in the city of New York. Besides a strong and well cultivated mind, she possessed all those endearing qualitites which render a wife and mother so valuable. She has left a husband, 3 daughters and 2 sons to mourn their irreparable loss. (Dec. 26, 1829)
- DIXSON, JOSHUA: Died on the 22nd ult. after a few days illness, JOSHUA DIXSON of Columbiana in the 80th year of his age, a member of the society of Friends. (Oct.2,1830)
- ELLIS, ENOS. Died on Mon. last, after a short illness, in the 68th year of his age, Mr. ENOS ELLIS, late a citizen of Hanover Twp. (Aug.11,1827)
- FAGAN, UPHEMIA: Died on Sat. last, the 29th ult. at her residence in Centre Twp., MRS. UPHEMIA FAGAN, consort of Mr. JOSEPH FAGAN, and on Sun. following her remains were interred in the Friends burying grounds, attended by a large concourse of friends and relatives. (Oct.6,1827)
- FIGGINS, SAMUEL: Died on Wed. last at his residence 2 miles below town, Mr. SAMUEL FIGGINS, inkeeper, after a short indisposition of the billious fever, leaving a wife and a number of small children to bewail their loss. On yesterday his remains were interred with Masonic honors, in the public burying grounds attended by a large concourse of friends and acquaintances. (Aug. 4, 1827)
- FISHER, PAUL: Died on Tues. last, after a lingering and very painful illness, which he bore with exemplary fortitude and Christian resignation, Mr. PAUL FISHER, a respectable citizen of St.Clair Twp. (Aug.4,1827)
- FLEMING, JOHN. Died at his residence in Wayne Twp. in this county, on Wed., morning about 4 o'clock, Mr. JOHN FLEMING, in consequence of a fall from a horse. He bore the name of an honest and upright citizen. (Nov.24,1827)
- FOX, HENRY: Died on Sat. the 29th ult. in Hanover Twp. in the 35th year of his age, Mr. HENRY FOX, of a billious fever. (Sept 5,1829)

The dec'd was a citizen of high respectability, esteemed by all who knew him. (July 3, 1830)
- HEACOCK, JAMES W. Died on Sat. the 8th inst, in the town of Salem, of a pulmonary consumption after a lingering illness, JAMES WINNAR HEACOCK, age 21y 2d. (Dec.15,1827)
- HINDMAN, JOSEPH: Died on the 20th inst at his residence in Fairfield Twp., Dr. JOSEPH HINDMAN. (Sept 25,1830)
- HOSTETTER, MARY: Died on Tues. the 23rd of Oct. last, at the town of Glaris, Stark Co., MRS. MARY HOSTETTER, consort of Mr. JACOB HOSTETTER, JR., age 36y 8m, lacking 6 days. She left a disconsolate husband and several small children, 6 sons & 1 daughter, to deplore their irreparable loss. (Nov.17,1827)
- KELLER, JACOB. Died on Tues. the 3d inst. in Centreville, in the 73rd year of his age, Mr. JACOB KELLER; he left a disconsolate widow, 9 living children and 33 grandchildren. His remains were interred on Wed. in the cemetery adjoining the town, on which occasion the Rev'd Mr. Voigd delivered a suitable concourse to a numberous assembly of mourning relatives and sympathizing friends. (Nov.7,1829) (Ed.note: Centreville now Carrollton)
- LATHROP, JAMES W. Died at Columbus on the 31st ult, Mr. JAMES W. LATHROP, Esq., a representative of Stark Co. (Feb.9,1828)
- LEE, BARBARA. Died on Sat. evening last, in Wayne Tp., Mrs. BARBARA LEE, aged 63y 11m, and about 12 hours later, MR. WILLIAM LEE, her husband, aged 81y 4d; on Mon. their remains were interred in the old burying ground adjoining this borough. Mr. Lee was a native of England, and served in the American Army during the revolution. He was much esteemed and respected by all who were acquainted with him. (Jan.12,1828)
- LEPPER, CAROLINE: Died on the 23rd of Feb. last, of a severe illness, CAROLINE VIRGINIA, dau. of WILLIAM D. LEPPER, JR., age 7m 13d. (Mar.1,1828)
- LEPPER, SUSANNAH: Died on Sum. evening last, after a severe illness, SUSANNAH AMELIA LEPPER, in the 22nd year of her age. On Tues. her remains were deposited in the German cemetery of this place, attended by a large concourse of sympathizing friends. (Jan.16,1830)
- MASON, MARYLES: Died on Fri. the 23rd ult. in Centre Twp., MRS. MARY MASON, Consort of Mr. CHARLES MASON, aged 50y lm 4d. She left a husband and 8 children to lament their irreparable loss. Her remains were interred on the succeeding day, when the Rev'd J. SHAEFFER preached a funeral sermon from Revelation 14,13. (May 1, 1830)
- MATTHEWS, SARAH: Died at New Lisbon on the 27th ult, SARAH AGNESS, dau. of JAMES MATTHEWS of Petersburg in this county, after an illness of 3 weeks, aged 20m 9d. (Dec.4,1830)
- MAXWELL, ADAM. Died on Mon. the 7th inst at 8 o'clock am at the residence of his father, in Buffalo Twp., Armstrong Co., Pa., ADAM MAXWELL, printer, in the 26th year of his age. (June 19,1830)

WILLIAM McKINLEY DEAD.

The Father of Ohio's Governor Lives to a Ripe Old Age.

William McKinley, Sr., father of Governor McKinley, died at his home on West Tuscarora street, Canton, early Thursday morning, after a two weeks' illness, caused by heart trouble. He was eighty-five year old. His wife survives him. The Governor and all members of the family were present when the end came.

William McKinley, Sr., was a descendant of a Scotch-Irish man on his paternal side and of an English woman. His father, David McKinley, came to America when 12 years of age. He served in the war of the Revolution, and was pensioned by the government. He moved from Mercer county, Pa., to Ohio in 1809, and was for many years manager of a blast furnace. William McKinley, Sr., was born in Mercer county, Pa., before his father left there.

Mr. McKinley was a hale and well to do business man. He started one of the first iron furnaces in Ohio and continued in that business during most of his life. His wife, Nancy, is now 83 years old. They celebrated their golden wedding several months ago. He leaves a small estate.

Wednesday morning, the 5-year-old daughter of Henry Beigler, of East Liverpool, was left for a moment alone in the house. Her clothing became ignited at the grate and she was fatally burned.
