Old Photos

In the early years of the twentieth century, Kodak offered a service of printing postcards from photos. These black and white postcards often show the family lined up in front of their homes, the young children, their new automobiles, businesses in towns and the list is endless of possibilities that can be found. Online, search for "real photo postcard" and the name of the community. Check the back of the postcard to see if it is divided in half with space for the address and a message. These divided-back postcards were not available until 1907, so this can help date the postcard. Have Fun Searching!

Probate Cases

Did you realize that Probate Cases were filed in three places! (Estate Records, Probate Journals and Probate Records) Familysearch.org has the microfilm online of Probate Journals Vol 1-2 (1852-1860) to Vol 12-13 (1882-1886), Probate Records Vol 1-3 1803-1819 to Vol 38 (1884-1886) and of course the Estate Records (1803-1900). CCARC has copies of the Probate Records Vol 1-3 and Vol 5 & 6.

Have you looked up a Probate Case on microfilm only to say the packet is missing? Now you have other places to research! One case #97, **Conrad Dotteries (Dotterers)**, had missing packet. I found the Probate Record Vol 1 pg 322 had the will. Reading the case tells you Conrad Dotterers had land in Columbiana County, Ohio but lived and died in Adams County, PA. This gives us another way of finding where your ancestor, who you knew had lived in Columbiana County, OH, but not where his family originated. What little clues we can find in court document!

In the name of God, Amen I Conrad Dotterer of Canowago Township in the county of Adams and state of Pennsylvania, being weak in body and advanced in age but of sound and disposing mind memory and understanding blefsed be God, and considering the many accidents that attend and will at length end this mordal life. 'Mystery Farm' Has Roots in History

The "Mystery Farm" which appeared in last week's Ledger turns out to be more than a farm-it's an interesting link with history.

The square, many-windowed house is of the earliest vintage, and served once upon a time as an inn on the Pittsburgh-Alliance stage coach line. It was built by Jacob Gilbert who died about 1832.

Today it is the home of Herman Swope, and is located on what is called Sand Bank Rd., a township road running between Roule 164 on the south and Route 14 on the north. Other residents are Mrs. Swope and her brother, Homer Detrow, widelyknown carpenter who has built many of the homes in this area.

The 140 acres are farmed by Swope and his son, Wilmer Swope, who lives on the next farm down the road. They do general farming, and keep 18 dairy cows and 600 chickens, retailing the milk and eggs in Youngstown.

The place is steeped in history. The Esterly Cemetery once was part of the tract, until deeded to the Friends Meeting in Salem. The house, when first put up by Gilbert, who may have been a soldier in the Revolution, extended only as far back as the middle chimney in this picture. The

addition between the middle chimney and back chimney was built around 1862 by Isaac Nichols.

All of the trademarks of the pioneer home are in the house-big, wide oak flooring, window sills and baseboards of poplar, cut stone basement, and huge logburning fireplaces at both ends of house. It contains 16 rooms.

After Jacob died, the Gilbert heirs sold the place to a Frederick family, and it was from the Fredericks that Isaac Nichols of Virginia obtained it. It was Nichols who built the main barn. He wanted something impressive, and he built if in the middle of the road, so no one could miss seeing it. The road, of course developed a detour around the barn. Its course was moved 40 feet to accommodate Nichols.

Herman Swope obtained the place in 1936 after a succession of owners, one of whom, John Yoder, built the straw shed in front of the main barn.

Roller Collection

Thad Lora was a early genealogist of Columbiana County history in our CCOGS group. We recently were given some of his collection. This picture and history were part of it. Can you imagine camping like they did. Most of them looked happy!

Samuel J Roller

Samuel J. Roller, a respected citizen of Hanover township, was born in Mahoning County, October 15, 1837. The son of Jacob B. and Margaret (Gilbert) Roller. At the age of eleven years Mr. Roller began working at the miller's trade with his father and on attaining his majority went to New Lisbon, Ohio - at which place he operated a saw mill until 1862. In that year he ran a flouring mill for a short time in West Fork, and in August enlisted in Company G One Hundred and Fourth Ohio Volunteer Infantry as a musician with which he served until the close of the war.

The nineteenth day of August 1864, he was taken prisoner near Atlanta, Georgia by the Texas Rangers, and stripped of everything but shirt and pants. Shortly afterward he became an inmate of the infamous prison pen of Andersonville, where for eight months and eight days he suffered untold tortures, the like of which caused the death of many of his unfortunate comrades. He went into prison weighing 175 pounds and when he came out his weight had diminished to about eighty pounds. While a prisoner he was changed around considerably after the fall of Atlanta. He, with a number of others, was loaded into box cars and transported to Milan where in the prison stockade, he experienced his greatest suffering from the intense cold and exposure.

He was transferred from Milan to Savannah thence to Blackshier, where the prisoners were put in an open field surrounded by a deep trench, which was carefully watched by cruel guards. They were sent to Savannah for exchange, but the transports not arriving, he was taken back to Blackshier, thence to Thomasville, and on to the Florida line, and in a short time to Albany—where they were obliged to march on foot, through the swamps and water, which caused great suffering. The time being the week of Christmas and the weather was cold and disagreeable.

He was returned to Andersonville, where he remained until April after which with others he was compelled to make various changes before his parole on the 28th day of April, 1865 at Lake City, Florida. After his parole he was sent underguard to Baldwin, at which place he breathed the air of liberty after his long incarceration. He then went to Jacksonville where he received an outfit of new clothing. After which he went on a river steamer to Fernandina for Annapolis where he arrived on the 14th day of May, 1865. After remaining in that city a short time and drawing \$61.75 commutation money, he was sent to Columbia where on the following June 16th, he received his discharge, afterward he returned to Salem, Ohio. Mr. Roller had in his possession, a pocket book - and a skillet - (small one) which he got in Andersonville and carried while in prison. The skillet he looks upon as a valuable article as it served him during the trying days of his prison experience.

Mr. Roller was married September 12, 1861 to Miss Caroline Heaton, who was born on December 30, 1840. To this union were born six children, all whom survive except the eldest son. Their names are Ada R. Reeder, Charles Emmer, Walter G., Homer H., Edith C. and Jessie (died May, 1867). Mr. Roller

is a member of the Grand Army of the Republic post of New Lisbon and with his wife is a member of the Trinity Reformed Church. May 3rd Mr. Roller was nominated by the Republican primary election for infirmary director, receiving a handsome majority over all competitors, March 1877 he purchased a piece of land and a mill in Hanover township and since that time has been in business here. He is an ardent supporter of the Republican party, and a man universally respected by the community in which he resides.



Who has looked at pictures of the New Waterford former business district. The businesses are on Silliman Street. In material from Charles Koch family a letter was found with the Silliman family history with early pictures. (The Silliman Family -- Pennsylvania and South Carolina Branches by Robert B Silliman) This can be found online.

John Silliman, oldest child of Samuel and Elizabeth Silliman, was born in Lancaster County, Pa, on 28 Jan 1813. When twelve yrs old, his parents left Lancaster County. In 1842 he was married to Nancy S Stevenson, who was born in Pittsburgh in March 1821. They lived in Pittsburgh until 1851 when John and his brother Robert moved to Columbiana County, Ohio, to an area known as Bull Creek. These two brothers laid out the town of New Waterford. They were instrumental in establishing the first Presbyterian Church in the area. John also was the owner of the first store in the town. In time he became quite a successful merchant.

In 1869 he moved to Blairstown, Iowa, where he again became engaged in the mercantile business. He was an active member of the Blairstown Presbyterian Church of which he was a deacon and trustee at the time of his death on 19 Aug 1879 His wife, Nancy died in Cleveland on 20 May 1900. Both Nancy and John are buried in the Allegheny Cemetery in Pittsburgh. John and Nancy had two sons, Samuel P and William S and two daughters, Elizabeth and Anna Mary. Below are pictures of Nancy, John and Anna Mary.

Robert Silliman, second son of Samuel and Elizabeth Silliman, was born in Lancaster County, Pennsylvania in 1815 and was 10 yrs old when his parents moved to western Pennsylvania where he grew up in Ross Twp, Allegheny County. He is listed in an 1839 Pittsburgh Directory as Robert Silliman, carpenter. In 1851 he and his wife Mary Ann, together with his brother John and his family, moved to Columbiana County, Ohio. Later he moved to Texas where he was living in 1859 at the time of his father's death. (His father died in New Waterford, Ohio at the home of his son, John on 24 May 1859.) Robert continued to live in Texas until his own death in 1891. His wife moved back to
